2021 Water Quality Report for City of Leslie

This report covers the drinking water quality for City of Leslie for the 2021 calendar year. This information is a snapshot of the quality of the water that we provided to you in 2021. Included are details about where your water comes from, what it contains, and how it compares to United States Environmental Protection Agency (U.S. EPA) and state standards.

Your water comes from three groundwater wells, each over 215 feet deep. The State performed an assessment of our source water to determine the susceptibility or the relative potential of contamination. The susceptibility rating is on a seven-tiered scale from "very-low" to "very-high" based on geologic sensitivity, well construction, water chemistry and contamination sources. The susceptibility of our source is Moderately Low Sensitivity.

There are no significant sources of contamination in our water supply. We are making efforts to protect our sources by participation in a Well Head Protection Program that was updated approved by the DEQ in 2016. We will continue to monitor our potential sources of contamination through the Well Head Contamination Program.

Contaminants and their presence in water: Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the U.S. EPA's Safe Drinking Water Hotline (800-426-4791).

Vulnerability of sub-populations: Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune systems disorders, some elderly, and infants can be particularly at risk from infections. Sources of drinking water: The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. Our water comes from wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture and residential uses.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.



In order to ensure that tap water is safe to drink, the U.S. EPA prescribes regulations that limit the levels of certain contaminants in water provided by public water

systems. Federal Food and Drug Administration regulations establish limits for contaminants in bottled

water which provide the same protection for public health.

Water Quality Data

The table below lists all the drinking water contaminants that we detected during the 2021 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing done January 1 through December 31, 2021. The State allows us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. All the data is representative of the water quality, but some are more than one year old.

Terms and abbreviations used below:

- <u>Maximum Contaminant Level Goal (MCLG)</u>: The level of a contaminant in drinking water below which there
 is no known or expected risk to health. MCLGs allow for a margin of safety.
- <u>Maximum Contaminant Level (MCL)</u>: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- <u>Maximum Residual Disinfectant Level (MRDL)</u>: The highest level of a disinfectant allowed in drinking water.
 There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- <u>Maximum Residual Disinfectant Level Goal (MRDLG)</u>: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Information about lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. City of Leslie is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Infants and children who drink water containing lead in excess of the action level could experience delays in their physical or mental development. Children could show slight deficits in attention span and learning abilities. Adults who drink this water over many years could develop kidney problems or high blood pressure.

Copper is an essential nutrient, but some people who drink water containing copper in excess of the action level over a relatively short amount of time could experience gastrointestinal distress. Some people who drink water containing copper in excess of the action level over many years could suffer liver or kidney damage. People with Wilson's Disease should consult their personal doctor.

Monitoring and Reporting to the Department of Environmental Quality (DEQ) Requirements: The State of Michigan and the U.S. EPA require us to test our water on a regular basis to ensure its safety. The City of Leslie has 793 water service lines which 250 are suspected lead lines.

City of Leslie Water update

For years the City of Leslie has struggled with ongoing complaints regarding water quality. These complaints started in 2013 when the City changed the water treatment process from aeration and detention to using a closed system which uses chlorine to oxidize iron. On 02/06/2017 the City of Leslie added an aeration and detention system to our water treatment system. Early testing of the distribution system had indicated that the aeration and detention treatment process was improving the quality of the water. I am pleased to say that the quality of our water continued to improve and by the end of May 2017 the results from the water samples that the Department of Public Works does daily indicated that we no longer had high iron in the water. It has been a little more than 4 years now since the aeration and detention was added and the water has continued to improve. We believe the issues with water that The City of Leslie has experienced in the past are behind us.

Instructions to Water Supplier

**Note: The CCR should contain the most recent data in the last five years.

- 1. Under "Level Detected" and "Range":
 - (A) enter the highest test result from the lab UNLESS a contaminant's compliance is determined based on a running annual average. Then, list the highest running annual average.
 - (B) range such as "12-48" (if you sample more than once or from multiple locations).
 - (C) enter the test result from the lab report for sodium, even if it was not detected.
- 2. Under "Year Sampled," enter the year sampled (if earlier than the year covered by the report).

- 4. If arsenic was detected above 5 ppb but at or below 10 ppb include the following:

While your drinking water meets the U.S. EPA standard for arsenic, it does contain low levels of arsenic. The U.S EPA standard balances the current understanding of arsenic's possible health effects against the costs of removing arsenic from drinking water. The U.S. EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.

5. If nitrate was detected above 5 ppm but below 10 ppm include the following:

Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant, you should ask for advice from your health care provider.

When this occurs, we are required to conduct assessment(s) to identify problems and to correct the problems that were found during these assessments.

E. coli are bacteria whose presence indicates that the water may be contaminated with human or animal wastes.
